They called the RSPCA and two officers came out and rescued the owl. It was taken to their office to check it over and make sure everything was alright prior to it being released. On further investigation by our bailiffs it is believed that the bird had been caught up for a day or two. Luckily our bailiffs happened along when they did.

Please do not leave any line on the bank. If you get snagged in the trees and it is possible and safe to do so try and remove the line.

## **Fisheries Team outing**





The Fisheries team organised a self funded day out fishing in mid October to celebrate another years hard work maintaining the BAA's fisheries. It is a tradition (for 2 years anyway) that we do this on a non BAA water, so about a dozen of us arrived at a day ticket fishery at Holme Lacy on the River Wye. The river was already in running high and coloured and continued to go up a further 3 feet during the day.

The fishing was difficult and had to be done close to the bank out of the main force of the flood. Barbel, roach, dace and chub were caught, mainly by feeder fishing but a couple of dedicated float fishers persisted where the swims allowed out of the main flood.

After being broken by what felt like a barbel early in the day your editor had no more bites. So towards the end of the day I left my rod to get a box of different bait, to turn around and see rod and reel disappearing down the Wye after what was probably a violent barbel bite. Well at least it gave me an excuse to buy a new barbel rod and reel and taught me a lesson for the future!



The day was completed with a fine Gurkha meal at the Roadmaker Inn at Newent.

# Hydropower scheme stopped

Fish Legal has won an historic injunction against a multi-million pound hydropower development on the River Trent at Sawley Weir, in the process exposing major failings in the regulatory process.

The membership association Fish Legal, acting for its member the Pride of Derby Angling Association (PDAA), has won the biggest case in its 64 year history by securing an injunction to stop impending construction of a flagship hydropower scheme at Sawley Weir on the River Trent. The case was heard at a four day trial in Nottingham County Court against developers the Small Hydro Company and the Canal and River Trust (CRT -previously known as British Waterways).

Fish Legal's expert lawyers and legal counsel fought the case on the grounds that the development would have destroyed the PDAA's 1,200 members' enjoyment of their prime stretch of river fishing on which they own the freehold rights. The Judge found that the developers and the CRT did not consult with the PDAA until very late in the planning process, and that they should have made much more careful enquiries about the fishing rights at the outset. Indeed it appears that the company and the waterways charity CRT turned a blind eye to those rights in an attempt to sideline those with most to lose from the scheme – anglers. The Judge recognised that they either ignored or were aware of the risks, both to the scheme and the fishing rights, but they pushed forward with their plans anyway.

If the scheme had gone ahead, the natural riverbanks would have been transformed into a 150 metre-long concrete and steel industrial facility with floodlights and alarms sounding off at intervals. Anglers were expected to access their fishing via a locked security gate into a fenced compound and to perch themselves and their equipment on a series of metal platforms suspended up to eight feet above the river. The developer's own health and safety witness conceded in court that this would put them "at risk of death". The Judge ruled that the club should not be forced against its will to accept the proposal at the expense of its valuable fishing rights and that the scheme should not go ahead.

The company had tried to pressurise the club to accept its plan and, in spite of the anglers' objections, pressed ahead with seeking an Impoundment Licence for the development from the Environment Agency (EA), which was granted.

The EA's decision to grant the licence has been roundly criticised by Fish Legal and the Angling Trust as a failure of the regulator to fulfil its statutory duty to consider and give due weight to fisheries when granting impoundment licences. In this case, its 'consideration' was limited to a single (unclear) sentence: "Part of Pride of Derby's fishery lies within the weir pool affected i.e. increased periods of reduced flow during operation of the turbine". This minimal level of attention is utterly inadequate from a public body which has a statutory duty to maintain, improve and develop fisheries (i.e. angling) and the Judge's decision that the fishing rights would be significantly harmed demonstrates the EA's failure in this regard.

What's more, by granting the licence, the EA handed the company a statutory defence to any claims against it for damage to the fishery caused by modifying water levels and flow rates. Fish Legal therefore had to limit its civil legal action to the narrower point of the impact on the club's access to the fishery and the physical ability of its members to fish

there, but they still won the case.

The scheme at Sawley was one of many being planned in the region by the Small Hydro Company, but there are also hundreds of others planned across the country by other private companies, often backed by private equity and major financial institutions, who are engaged in a gold rush to make profits from generating hydropower principally because of generous feed in tariffs from the taxpayer.

Even if all the 26,000 sites identified by the EA which might be suitable for hydropower were to be developed, they would still generate less than 0.5% of the nation's electricity supply but would have a major strategic impact on fish and fishing. Low head hydropower therefore makes a negligible contribution to tackling climate change, but has a very significant impact on freshwater ecology. Taxpayers' funds would be far better spent on promoting energy efficiency, where no such unequal 'tradeoffs' are required.

The club would never have been able to fight the case without the support of Fish Legal, which met all the costs and risks, which could have totalled hundreds of thousands of pounds if the developers had won. This is only possible because of the fighting fund accumulated over decades from the donations and membership subscriptions of tens of thousands of anglers and angling clubs. There is no chance that the club could have stood up to the might of the developers and their expensive lawyers without Fish Legal's unique legal protection (an appeal, which would increase the legal costs yet further, is still possible).

Coincidentally, Fish Legal (then called the Anglers' Co-operative Association) was founded back in 1948 shortly before winning a landmark case against pollution for the Pride of Derby Angling Association against British Celanese Ltd in 1952, and then on appeal to the Court of Appeal. PDAA member George Elliott joined the ACA at the time and is still an individual member of Fish Legal and the Angling Trust to this day.

**George Elliott said**: "Thankfully Fish Legal was able to defend our fishing from this terrible development. I have fished at Sawley weir for decades and have caught barbel, pike, carp, chub, dace, perch and roach from the weirpool. I am so pleased that we will be able to carry on fishing there in the future. It was quite ridiculous to suggest that we should have to fish from metal platforms above the river. Every angler should be a member of the Angling Trust and Fish Legal – together they take action to protect our fish and fishing."

Andrew Kelton, Fish Legal Solicitor, said: "I hope that developers will learn from this landmark case that it is vitally important to discuss any proposals at the earliest possible stage with angling clubs who own or lease fishing rights on rivers. If they don't, they could find themselves in court and having to tear up their expensive plans."

Mark Lloyd, chief executive of Fish Legal and the Angling Trust said: "We are delighted to have been able to defend one of our member angling clubs in this historic case against an aggressive developer, who was granted an impoundment licence by the so-called Environment Agency to spoil a beautiful river and a prime fishing spot with an ugly, environmentally-damaging turbine purely to turn a profit out of taxpayers' subsidies. Even a thousand of these schemes would make a negligible contribution to tackling climate change, but each one would have a significant impact on the water environment."

**Keith Fisher, the Vice Chairman of the angling association**, having been questioned for three hours in court by the developers' QC, said that: "it was a relief that it was all over and that the bully boy tactics used by the developers had not won through".

Alan Miller the secretary of the Pride of Derby Angling Association said: "It's quite a relief that we have won and this special place for fishing is protected for future generations of our members. Some of our members travel considerable distances to fish at

this spot. We are truly grateful for all the hard work and dedication that has been put in by the Fish Legal team".

# Angling Trust media release

## Fishing for Life Strategy launched at Angling Summit

A strategy to get more people fishing and help projects that use fishing to provide support to people in need was launched at the Angling Summit in London today.

The new strategy, Fishing for Life, was launched by Fisheries Minister Richard Benyon to encourage more people to try angling. The Environment Agency and Angling Trust developed the strategy that builds on angling's proven ability to promote wellbeing, support local communities and contribute to the economy.

As part of the development of the strategy, two national surveys were carried out by research organisation Substance which involved more than 29,000 anglers and 780 organisations working in angling. The results of these surveys were presented at the Summit.

#### The Summit heard:

- how fishing is helping young people learn to concentrate, take responsibility and achieve better results at school;
- the benefits that people derived by disabilities, recovering war veterans and the mentally ill from learning how to fish, and how to meet their needs;
- the need for access to local waters so that people can regularly benefit from going fishing, and the possibilities for community groups to build angling into regeneration plans;
- the importance of healthy freshwater and marine fish stocks to the future of angling participation;
- the need to promote the benefits of angling to a wider audience.

The strategy will be delivered over the coming years by a wide range of organisations working together to develop plans to deliver the four elements of the strategy:

- Encouraging people to take up and continue fishing so it becomes a habit for life getting the fishing habit;
- Recognition of angling's role in improving the nation's health, increasing educational attainment and reducing crime and anti social behaviour **transforming and**

#### changing lives;

- Improving people's lives by using angling as a catalyst for bringing people and society together - focus on people and places;
- Recognising that fish and fishing are at the heart of a better environment hands up for the environment;

#### Fisheries Minister Richard Benyon said:

"As a keen angler myself, I am delighted to be involved with such a worthwhile project. Angling is a great sport for men and women of all ages - it's enjoyable and it gets you outside, enjoying our wonderful waterways and seas and getting all the health and wellbeing benefits from being outdoors."

### Mark Lloyd, chief executive of the Angling Trust said:

"Working on this strategy has been an inspirational experience for us all. There is so much fantastic work being done throughout the country to use fishing to transform people's lives and to protect wonderful watery places. Our job now is to use the strategy to make other people aware of angling's many benefits and to encourage organisations to work together locally and nationally. We are very grateful to the tens of thousands of anglers and the hundreds of angling organisations which have contributed to creation of this exciting new strategy."

# Politicians speak their minds in The Angle

Angling Trust secures strong political support on bass, cormorants, hydropower, unlimited canoe access and a new Charter for Angling.

Angling Trust campaigns chief and ex-MP Martin Salter went back to the party political conferences to make the case for fishing and to take the political temperature on the issues that are important to anglers. He came away with some highly significant pledges in exclusive interviews for the Trust's member's magazine 'The Angle' with three of the politicians who matter most to angling.

On cormorants and hydropower the new **Environment Secretary Owen Paterson** showed that he was on the side of responsible anglers who want to do the right thing by the environment and invited the Trust to work with him on a Government review of renewable energy projects.

On anglers' concerns over hydropower Owen Paterson said: "Of course there's a role for hydropower in the energy supply mix but we must work with the grain of nature and not against it and I'm not at all happy about schemes that reduce river flows to environmentally damaging levels and contain 'fish mincing turbines'.

Anglers are right to be concerned about damage to fish stocks and this is just one of the reasons why the government will be announcing a review of renewable energy policy. I can assure you that there will be a robust submission by Defra to which the Angling Trust will be most welcome to contribute."

Mr Paterson also had some encouraging words for anglers campaigning for better protection for fisheries suffering from cormorant predation. He said: "There's a review underway in my department precisely because we realise that there are real problems on many of our fisheries. I can assure you we will be decisive and I am on record as saying we must never be frightened of managing our wildlife where appropriate.

I know of successful businesses that have been badly damaged by excessive predation by cormorants and we must give our inland fisheries the protection they need to remain healthy and productive."

Then **Fisheries Minister Richard Benyon** gave a cast-iron commitment to resist the campaign by the British Canoe Union (BCU) to trample over anglers' rights with a statutory 'right to paddle' in every river and stream in the country and had some warm words for those campaigning for improved bass conservation.

On canoeing Mr Benyon said: "I want to be really clear about this. While we want more people to get out and enjoy activities in the countryside they must be complimentary. There are plenty of places to canoe where it is appropriate and others where it is not. There will be no change to our policy of supporting voluntary access agreements as the only way forward. Anglers and fishery owners spend a lot of time and money caring for our rivers and streams and their rights deserve to be respected."

Turning to the bass minimum landing size: "I have this old fashioned view that creatures should be allowed to breed at least once before we seek to harvest them for food. That's why I authorised the review of the current bass minimum landing size and we shall have to see what that throws up."

Martin Salter also interviewed the Shadow Fisheries Minister Tom Harris at Labour's conference in Manchester.

Tom Harris reconfirmed his party's support for angling saying: "There are real benefits for the whole community in having an army of passionate advocates for the environment out there on the banks of our lakes, lochs, streams and rivers. Anglers are a great early warning system and government should make more use of them and their knowledge and expertise.

He pledged to update Labour's Charter for angling ahead of the next general election saying: "I want to work with all the angling bodies on a policy that positively promotes angling and encourages more young people, in particular, to take up the sport.

The Angle is sent to all clubs and fisheries affiliated to the Angling Trust and Fish Legal and to their 15,000 individual members.

**Martin Salter said**: "Most of us go fishing to escape from work and politics but there's no escaping the fact that the hard work we've put in to building relationships across both sides of politics in the UK is paying off. There's some really significant stuff in all these interviews with Owen Paterson making it clear that he recognises our case on key issues such as hydropower and cormorant predation. For Labour, Tom Harris couldn't be more supportive and wants more young people to take up the sport while Richard Benyon doesn't pull his punches on unauthorised canoeing or the need to preserve our bass stocks and estuaries.

We are also doing some great work with George Hollingbery MP, the new chair of the All Party Angling Group at Westminster and I think it's fair to now claim that angling in this country has never had such strong influence now we are professional and united."

Mark Lloyd, chief executive of the Angling Trust added: "Getting interviews with politicians at this level would have been unthinkable for angling organisations before the formation of the Angling Trust four years ago. The combined effect of our growing membership and Martin Salter's political skills mean that anglers now have a serious voice in the corridors of power. I know that there are thousands of anglers who have been waiting to see whether or not the new unified body for all anglers will have any real influence before they become members. We need their support today so that we can press home vitally important arguments about the future of fish stocks and fishing."
